

DiamondLiving Underlayment Limited Lifetime Warranty

DiamondLiving, LLC Underlayment is guaranteed to be free of manufacturing defects in material and workmanship for 20 years from the original date of purchase, by the original purchaser (referred to as the Warranty Period). This warranty is not transferable. If there are defects in material and workmanship during the Warranty Period, DiamondLiving, LLC will replace or repair the product, as described herein, at no cost to the owner. Should defects in material or workmanship be found, it is the owner's responsibility to contact DiamondLiving, LLC through the point of purchase or directly, as described below. This warranty does not cover dissatisfaction or problems or other damage to the materials due to or as a result of:

a) Improper installation, improper maintenance, or usage not approved by DiamondLiving, LLC;

b) Use of harsh and acidic chemicals and abrasive chemicals;

c) Water spotting, petroleum adhesives or floor sealants or abuse;

d) Wear or product degradation expected from the use or environment of installation;

e) Chewing, clawing or other animal destruction;

f) Exposure to chlorine, solvents, acids, or other harmful chemicals; org) Misuse of the product;

h)Accidental or intentional acts causing damage including, but not limited to, scratching, severe impacts, cutting, negligence, fire, flooding, acts of God, improper fabrication, improper installation, improper maintenance, freight damage, extreme temperatures, and planks being engaged or disengaged more than three times;

Proof of Purchase is Required

- This warranty is limited to the repair or replacement of productsof DiamondLiving, LLC which are shown to be defective during the Warranty Period. The owner agrees not to advance any claim for any other measure of damage or loss. DiamondLiving, LLC shall not be liable for installation, disassembly, removal, disposal, return shipping, or other similar costs.
- This warranty does not cover the replacement or removal of cabinets, appliances, furniture, or other fixtures.
- DiamondLiving, LLC shall not be liable for any damage, loss or claim whatsoever unless:

a) The manufacturer is notified in writing within thirty (30) days of any occurrence which might give rise to a claim;

b) The owner has obtained written authorization from DiamondLiving,

LLC prior to making any repairs or alterations on or through the surface which may affect the integrity of the materials;

c) DiamondLiving, LLC is first permitted to inspect the allegedly defective product or cause of the alleged loss, damage or claim; and

d) The material is installed according to the written instructions provided by DiamondLiving, LLC and used only as intended by DiamondLiving, LLC.

• If, after inspection, DiamondLiving, LLC determines that there has been a material defect in the product within the Warranty Period described above, the liability of DiamondLiving, LLC and the remedy of the owner shall be limited, at the sole option of DiamondLiving, LLC to either: (1) delivery of repair or replacement material for the impacted area, or (2) credit to be applied towards the purchase of new material. The value of either remedy shall be pro-rated upon the remaining months of unexpired warranty as determined by the manufacturer. The maximum pro-rated value of either remedy shall in no case exceed the original purchase price.
